## Re Porcupine Caribou Annual Harvest Meeting 2025

As you are aware, the PCMB is responsible for convening our Annual Harvest Meeting (AHM) during the second week of February each year, as agreed to in the *Harvest Management Plan for the Porcupine Caribou Herd* (HMP).

The 2025 AHM has been scheduled for February 11 and 12 in Dawson City, Yukon at Tro'ndëk Hwëch'in Community Hall which is located at 1242 Front Street. The **public portion of the meeting will take place on February 11** starting at 9:00 a.m. As usual, the public session will be followed by a closed meeting of the PCMA Parties and the PCMB the following day.

The intent of the public meeting is to bring together stakeholders, the general public, and PCMA Parties to exchange information about the herd and discuss the most recent status report provided by the Porcupine Caribou Technical Committee (PCTC).

Following the public meeting, the PCMB will meet with the PCMA Parties only in a closed session to deliberate on the information presented, after which the PCMB will make its determinations. The PCMB's recommendations with respect to the harvest management regime according to the colour zones outlined in the HMP will be forwarded to the Parties within 30 days of the meeting. The PCMB recommendations will be distributed to the public after a further 15 days, to allow Parties opportunity for initial review.

The PCMB is requesting that any information that it should consider when assessing the status of the herd be provided by **January 20, 2025.** This would include local and traditional knowledge from organizations or community members. A template to assist with developing submissions is available online on the PCMB website. Further information related to submissions can be found in the AHM Operating Procedures, Appendix B.
